Consider and take appropriate action on a resolution authorizing the expenditure of funds for the purchase of rifle-resistant body armor in accordance with the State of Texas Rifle-Resistant Body Armor Grant Program.

DESCRIPTION:

City Council shall consider a resolution authorizing the purchase of rifle-resistant body armor for sworn law enforcement personnel in the amount of \$52,610.25. This expenditure is compliant with the State of Texas Rifle-Resistant Body Armor Grant Program and is subject to full reimbursement upon successful award of the grant. The equipment purchase will enhance officer safety and ensure compliance with state guidelines for protective equipment.

BACKGROUND INFORMATION:

The Police Department's current inventory of rifle-resistant body armor has reached its expiration date and is no longer compliant with current safety standards. To maintain operational readiness and officer protection, replacement of the armor is necessary. The City is eligible to receive reimbursement for these purchases through the State's grant program.

The grant application has been submitted, and the City anticipates full reimbursement of the \$52,610.25 following approval by the Office of the Governor. The authorization of this expenditure in advance ensures that equipment can be procured in a timely manner, minimizing any risk to officer safety due to expired gear. This grant was previously awarded to the City in 2018.
